The Handicrafts Sector is able to provide substantial direct employment to the artisans and others engaged in the trade and employment to many input industries in recognition of the above facts, the Government of India set-up an autonomous All India Handicrafts Board in 1952.

The promotion of handicrafts industries is the primary responsibilities of State Governments. However, the Office of the Development Commissioner (Handicrafts) has been implementing various departmental schemes at the central level to supplement state's activities in the handicrafts sector besides the new thrust areas.

The Office of the Development Commissioner (Handicrafts) functions under Ministry of Textiles for promotion and exports of handicrafts. The office is headed by Development Commissioner (Handicrafts). BACKGROUND OF THE PROGRAMME

Handicrafts constitute an important segment of the de-centralized/unorganized sector of our economy. It is mainly a rural based sector which has its reach in backward and in accessible areas. Originally, handicraft started as a part time activity in the rural areas, however it has now transformed into a flourishing economic activity due to significant market demand over the years. Handicrafts have big potential as of hold the key for sustaining not only the existing set of millions of artisans, but also for increasingly large number of new entrants in the crafts activity. Presently, handicraft sector is contributing substantially towards employment generation and exports but this sector has suffered due to its unorganized nature along with additional constraints like lack of education, capital, and poor exposure to new technologies, absence of market intelligence and poor institutional framework.

Exquisite master-piece handicraft items with substantially high artistic content should command a higher price in the market. Such high-premium medium- volume handicraft products should be positioned in the niche market through strong promotional and advertisement efforts with development of "Handcrafted in India" mark. Which will create the willingness in customers to pay a much higher price The artisans in the segment will also be supported through direct assistance for tool-kits, education, social security etc.

Utility-based home décor and furnishing handicraft products will need introduction of substantial technology and mechanization of parts of the manufacturing process thereby enabling mass production quality-enhancement and cost-reduction to face the challenges of global competition.



AIM AND OBJECTIVE OF THE PROGRAMME

This Craft Demonstration Programme (CDP) aims to provide to organize interaction programs to promote handicrafts with the general public. It is an initiative taken to support local level awareness that target general public, art loving people and spread awareness about the crafts where the reach of such wider audience can be ensured. The participants get an opportunity to have a better perspective and a more hands on understanding of our rich heritage art and culture

It is conceptualized that experts/master crafts persons in different crafts will be deployed in the programme with a view to introduce the beneficiary participants about the craft, share essential Course material related to the respective craft & train them with their active participation by making live demo in each of the crafts. Through the medium of live demonstration of their art, artisan shared with the visitors, the process of making of their handicraft products.

The main objective is to organize live demonstration / making of artifacts to promote handicrafts among general public. Demonstration program will help general public to understand complex skill, hardship and creativity involved in making artifacts. This will induce buying urge for handicrafts items among public and simultaneously artisans can build up their business relations.



NEED OF THE PROGRAMME

Craft Demonstration Programme is very important to spread awareness by initiating a live interaction among participants and master crafts persons or experts which introduce their crafts and culture among new generation because Handicraft is a useful skill that adds beauty in our life. It helps to our new generation to learn these skills and apply in their life. During Craft Demonstration Programme, new Artisans can learn a new skill. They can earn from it. They can develop their product and market them. Craft Demonstration Programme will help in income generation and economic empowerment.

In this programme, the focus is on live practical sessions which help participants to understand the process of art or craft; this gives a clear image of process of making of the crafts by experts. In this programme, artisans prepare their products in a continuous manner, so that people can see the making of the products and understand the minute details regarding the same. In our country, Handicrafts is an important part of our rich cultural heritage, which serve to satisfy the aesthetic needs of man and provide a vehicle for his urge for self-expression.

Organized by All India Parivartan Sewa Samiti Delhi. Sponsored by O/o the Development Commissioner (Handicraft) Ministry of Textiles, Govt. of India. vide their Sanction No : C-12011/13/2021-22-CC-(NR)-AC-3 Dated : 09/12/2021. for the Cluster Artisans of the Adopted Cluster of Carpet & Other Floor Covering Crafts Under AHVY Scheme.

The Craft Demonstration Programme was inaugurated on by Shri Abhimanu HPO HSC Kullu in Presence with Smt. Ramana Devi, Jai Prakash Jha, Shri Naresh Kumar, Shri Dinesh Kumar Pal, Shri Murli Dhar Jha Shri Lalit Babu and Beneficiary Artisans.

Shri Abhimanu HPO HSC Kullu Briefed The District Profile And Its Name And Fame To Develop Craft Sector. He Thanks All India Parivartan Sewa Samiti To Organise Craft Demonstrate Programme To Recreate The Interest In The Traditional Crafts. He Also Highlighted The Key Features Of Handicrafts Including The Contribution Of Kullu, In This Sector. He Further Spoke About Awareness Of Handicrafts Office, Bankers And Asked Participants To Make Utilize Of Facilities Available To Artisans Community For Betterment Of Their Life.



Shri Abbimanu further informed that aim of the Office of the Development Commissioner Handicrafts under the Ministry of Textiles is undertaking various developmental activities under the umbrella scheme titled "National Handicrafts Development Programme" [NHDP] such as enrolment of artisans, formation of artisans into SHGS/Federations /Societies imparting training to them, conducting workshops to develop new designs, helping them in domestic marketing, promoting exports, R&D activities, creating common Infrastructur, providing credit facilities and taking welfare measures for artisans etc to promote Handicrafts and address the problems and challenges being faced by the sector.

The Officer of Handicrafts Department and Resource Persons delivered the speeches on Welfare Schemes for Artisans, Information regarding Handicraft Artisan Card was also given to all the participants during the programme. The registered artisans were given information regarding benefits they can take because of their artisan card. All the participants who were interested in applying for the artisan cards were given full information related to it, during the programme.

Shri Abhimanu HPO HSC, Kullushared his experiences and said that how this sector changed his whole life. He said that Carpet Craft is one of the many famous Indian art forms under Kullu HSC. The Himachal pradesh state of India has been a center of art and culture since ancient times. It had been a home to various kinds of crafts.



The art is very popular in Himachal Pradesh, especially in the Kullu district among the women. The skill is being passed across the generations as it is a very old craft. The young girls learn it from their grandmothers or mothers. It is mainly a women's craft.

All the dignitaries, guest resource persons visited the stalls. During this programme all the master craft person and artisans interacted with the guest resource persons. They were also raised their queries, and questions about the craft and got a relevant response from resource persons. They were informed regarding handicraft Scheme, bank loans, Design improvement of product, market research etc.

On this occasion master craft person and artisans were appreciated for their live demonstration and products displayed by them. The whole programme was very fruitful & meaningful for all the artisans and stakeholders.



LIVE DEMONSTRATION/INTERACTIVE/ PRACTICAL SESSIONS

During the programme, all the Master Artisans shared their experiences about the Handicraft Work. Then all participants present in the Programme interacted with a group of Master Artisans at venue during the workshop exchanging the knowledge and design practices. The interaction resulted into various crafts narratives. These narratives were translated into illustrations using Work techniques in collaboration with Master Artisans.

These interpretative narratives were applied to typical Indian day to day products creating a new range of contemporary products, there was an inter-generation knowledge sharing that took place through this Programme. During the programme, the Master Artisan gave training, instructions and guidance to participants to make Carpet and other floor covering crafts etc.

In the two Days live demonstration programme, Organized at - Hall of Highway Cottage Home Stay, Village - Mohni, Anni, Kullu (H.P). Dated 24-02-2022 & 25-02-2022. artisans prepared new items every day to show their talent, efforts and labour which is invested while making the product. Total 20 artisans participated in Craft Demonstration Programme and total sale 2,20,380/- out of the total stock value rupees 3,16,000/-



The Officer of Handicraft Department and Resource persons delivered their Speeches to spread Awareness about indian Handicraft and the Heritage, Culture and tradition associated with it and awareness about Schemes/Benefits available to the artisans. History and importance of Carpet, Craft tools and technics of Carpet, Design Development, Marketing, Communication Skill etc. all the master craft person and artisans present interacted with the guest/resource person. 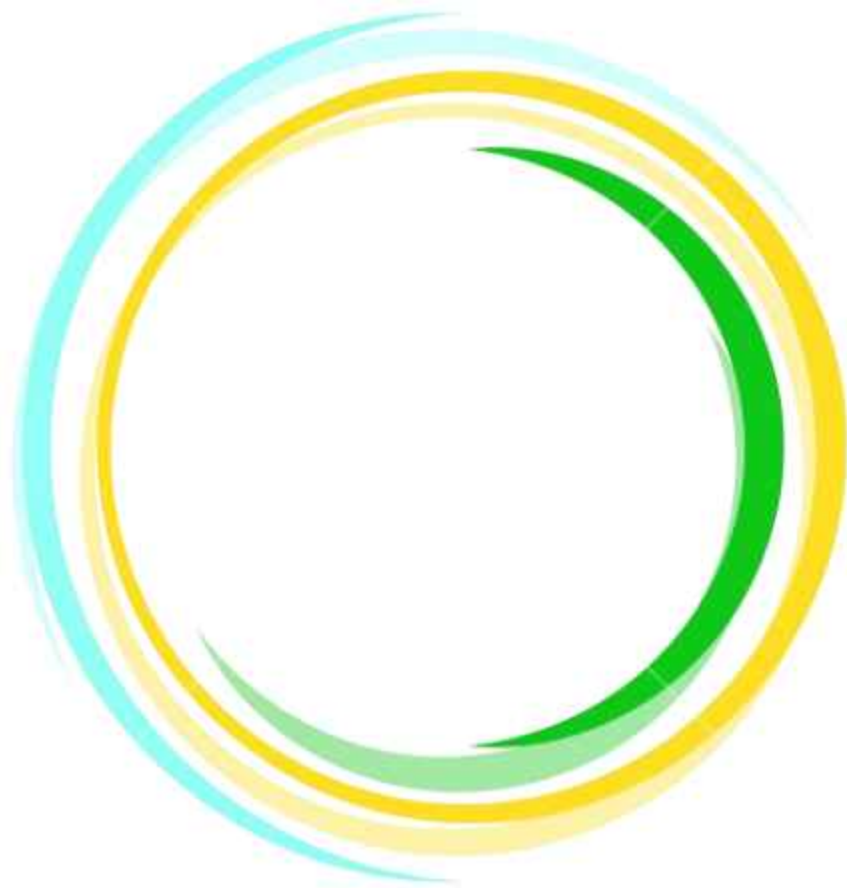
